

RESOLUTION NO. 868

**A RESOLUTION AMENDING RESOLUTION 810
REGARDING FEES TO BE CHARGED IN RELATION TO BERTHUSEN PARK,
CITY PARK AND BENDER FIELDS
FOR THE CITY OF LYNDEN, WASHINGTON**

BE IT RESOLVED by the City Council of the City of Lynden, Washington that Resolution 810 be amended in its entirety, to read as follows:

(NOTE: THE FOLLOWING AMOUNTS ARE IN U.S. FUNDS ONLY.)

Section 1: The park charges contained in Resolution 810, adopted January 10, 2010, are hereby enacted, confirmed and ratified effective January 7, 2013.

The Council hereby declares that it would have passed this code and each section, subsection, sentence, clause and phrase

thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases had been declared invalid or unconstitutional, and if, for any reason, this Resolution should be declared invalid or unconstitutional, then the original Resolution or Resolutions shall be in full force and effect.


Section 8: This Resolution shall be in full force and effect on seventh day of January, 2013.
